  - a. Income

7. **Fundraising committee Pansy and Mum Sale:**
  - Marcia is going to handle the vendor and handle distribution day (still need 5-7 volunteers), Marie is going to learn and handle the technical stuff (online store setup, order spreadsheet and PayPal. Liz will be training her and will serve as her backup) and Debra is going to handle Marketing (Friday Flash/Newsletter postings and signs).
  - We won’t have firm dates for the sale or distribution day until Marcia has spoken with the vendor. We should have firm dates by end of this month.
  - This fundraiser generally nets \$1k annually and is our most successful fundraiser of the year. Your help on distribution day is always needed and appreciated.

  - a. **Membership Drive** launches on September 1. Annual renewal dues must be paid by November 1 in order to vote on new officers for 2023. We currently have **62** dues paying members/families and that compares to the 2019 total of 74 in July of that year.
